APPLICATION FORM

Eligibility Criteria

- Students who have successfully passed Std. X (SSC) with a **minimum overall score of 80%**.
- Students who have family income **less than Rs.10000/- per month**.
- Students who currently reside and study in **Mumbai, Navi Mumbai and Thane** area only.

Documents Required

- One attested copy of SSC examination mark sheet
- One passport size photograph
- Monthly salary slip of last 3 months of earning member/s **OR** Income declaration in format given below
- Proof of permanent residence (Ration Card/ Election card/ Electricity Bill/ Telephone Bill)

The completed application form should reach Merck Limited office **within 15 days** of the declaration of SSC results. Forms that are incompletely filled and those without the required supporting documents will not be considered.

Selection Process

- Applications will be screened on the basis of the eligibility criteria stated.
- Only selected students will be informed by email or telephone on the selection for the first round of Interview
- Candidates who make it through Round 1 are interviewed by the Board of Trustees, who select the students best qualifying for the scholarship on the basis of the eligibility criteria as well as their assessment of the students' ability and drive to study further.
- The decision of the Board of Trustees is final and no further disputes are entertained.
