A. Applications are invited from eligible candidates for **Full-time Institute sponsored PhD research fellowship** in various disciplines and categories.

B. ELIGIBILITY

1. M. Tech./ M.E.in relevant discipline with at least 6.5 CGPA in 10 point scale or 60 percent marks in aggregate in the M.E./ M. Tech. level from a recognized technical institute or university.

2. B. Tech/ B.E. in relevant discipline with at least 7.0 CGPA or 65 percent marks in aggregate from a recognized technical institute or university.

3. M. Sc. in relevant discipline with at least 6.5 CGPA in 10 point scale or 60 percent marks in aggregate from a recognized institute or university.

5. The minimum CGPA/marks to be relaxed by 0.5 CGPA or 5 percent in case of candidates belonging to the SC/ST categories.

6. GATE / CSIR-UGC NET / DBT Qualified or other admission tests conducted by Government of India agencies for admission to PhD programme is mandatory as per MHRD norm for candidates not having M. Tech./ M.E. degree.

7. For admission to Engineering and Science disciplines (except Life Science), a candidate should have passed Mathematics in +2 Science.

8. Science students admitted to Ph.D. programme in Engineering need Mathematics in +3 level.

NOTES:

- For selection of Research scholars in engineering disciplines, Students with B.Tech. degree will be given preference over students with M.Sc. degree, even if the latter has an M.Tech. Degree.
- Students with any other relevant background may be eligible, but only with approval of Chairmanof Senate on the recommendation of the Board of Research (BoR).
- Differential academic qualifications across the departments have been made considering the departmental requirement,

availability of candidates in the respective departments and uniform growth of all departments in the Institute.

Students of one discipline may seek admission in a related department which will be considered on the basis of merit of the case. Selection will be made on the basis of academic record, relevance of qualification, <u>candidate's research interest</u> (please visit faculty profile of the department), existing research programmes and facilities of the departments, and performance in tests and/or interviews.

C. FINANCIAL SUPPORT

Institute Fellowship as per the present norms of MHRD, Government of India (vide letter no. F.17-2/2014-TS.I dated March 02, 2015) shall be available to all selected Institute sponsored PhD research scholars, depending on qualification.

Fellowships will not be awarded to candidates above 32 years of age for Ph.D. (35 years for SC/ST and women candidates) on July 01, 2015.

D. APPLICATION PROCEDURE

Candidates applying for Ph.D. programme can apply through the downloaded application formavailable at <u>www.nitap.in</u>The filled up application form along with self-attested photo copies of marksheets,

degree certificates, community certificates, and the necessary enclosures along with anon-refundable application fee of Rs.500/-(Rs.300/- for SC/ST/PH) by means of Demand Draftdrawn not earlier than 25-07-2015, in favor of "The Director, National Institute of Pradesh" payable Technology, Arunachal at SBI. Niriuli (SBIN0009535), should reach to 'Dean (Research & Consultancy); Research & Development Cell, National Institute Technology Arunachal Pradesh 791112, Yupia, ArunachalPradesh, India' on or before 25-08-2015 in a sealed cover super-scribing "Application for Ph.D. Programme (with fellowship), 2015-16 in Department of **Applications** ". without the superscript shall not be accepted. If one desires to apply to more than one department, separate applications need to be sent.

Applications reaching after the due date shall not be accepted.

F. APPLICATION CHECKLIST

The completed application must accompany the photocopies of the following documents:

i) Self-attested copy of GATE/ NET score card (both sides) (> qualifying cut-off marks), if applicable

ii) Self-attested copy of marks sheet / Grade card of the standard X, XII and other university examinations. If the markssheetof the final

examination is not available, the marks-sheets of the previous semesters should be submitted.

iii) Self-attested copy of proof of date of birth

iv) Self-attested copy of community certificate in the case of SC/ST candidates from a competent authority (not belowthe rank of a Tahsildar), if applicable.

v) Self-attested copy of recent community certificate in case of OBC candidates from a competent authority (not belowthe rank of a Tahsildar) indicating the status regarding creamy layer, if applicable, issued on or after 01/01/2015.

vi) Self-attested copy of certificates from competent authority for persons with disability (PWD)

An application without the photocopies of the required documents is liable to be rejected.

G. SELECTION PROCEDURE

A short-list of candidates will be posted on Institute website. All shortlisted shall take a written admission test/ viva voce conducted in the concerned department. No admit card will be issued and all information related to admission shall be communicated through thewebsite. Visit <u>www.nitap.in</u> regularly for announcements related to PhD admission.

A student may apply for more than one programme in separate application forms. He/she should, however, keepthe dates of admission test/viva voce inconsideration. The admission test / viva voce shall be conducted in all departments simultaneously as per schedule. No traveling allowances will be paid to the candidates called for vivavoce / the test. No accommodation will be available at NIT Arunachal Pradesh during the viva voce / the test.

The decision of the respective department will be final in matters related to the preparation of the short list and merit list. Queries, if any, should be directed to respective department.
