Rules and Regulations for the award of Scholarship:

A) Rules for applicants seeking admission to first year engineering degree program.

- 1) The KJ's Educational Institute (hereafter referred to as "The Trust") shall publish the quota for applications, prescribe the format for applications, make blank applications available and arrange to centrally receive all the applications for the award of scholarships.
- 2) The applicant could be from any caste, creed, religion and gender.
- 3) The applicant must seek admission through central single window admission process conducted by the competent authority of the Maharashtra state, i.e. Commissioner, State CET cell, Maharashtra State, Mumbai, to any one of the three Engineering Institutes run by the KJ's Educational Institute, Pune.
- 4) The qualifying marks for the applicant would be considered as an average aggregate percentage marks obtained by him or her in the subjects of Physics, Chemistry and Mathematics taken together at one and the same attempt, in the qualifying examination for admission i.e. 12th Science.
- 5) The applicant would be eligible for the award of scholarship under the following terms and conditions.

4.1) The following table indicates the amount and minimum % of marks for the eligibility for award of maximum possible amount of Scholarship.

Sr. No.	Maximum amount of scholarship to be awarded to a student for the year of award	Eligible Qualifying Marks* (Without rounding off to the next percentage)
1	Rs.100,000/-	80 % & Above
2	Rs.75,000/-	75 % & Above
3	Rs.50,000/-	70 % & Above
4	Rs.25,000/-	65 % & Above

*Qualifying marks are the marks are as defined in 3 above.

4.2 The Scholarship would be awarded after the confirmation of admission of the applicant by the competent authority of the Maharashtra state (Pravesh Niyantaran Samitee), to any one of the three Engineering Institutes, run by KJ's Educational Institute, Pune

4.3 The applicant will undertake to attend all theory, practical and Tutorial classes for more than 85% of the classes held in each subject head, during the year of award.

4.4 The applicant will also undertake not to participate in any untoward incidence on the campus or outside, like common off, strike, etc. which may lead to disciplinary / legal actions.

4.5 The applicant shall not apply for a change of course / college during the entire course of study. In case if he or she desires to do so then he/ she shall undertake to pay full fees for entire duration of the course and also undertake to refund the scholarship received by him or her.

4.6 The applicant will be eligible for applying to avail the same amount of award of scholarship in the subsequent academic years provided the awardee

a) Attend more than 85% of theory as well as practical classes of all individual subject heads during the academic year of award and

b) Pass in all the subject heads in the examinations conducted by the affiliating university during the academic year of award and

c) Must score a minimum of 55% or more marks in the aggregate of all subject heads taken together at the examinations conducted by affiliating university at the end of academic year of award.

4.7 If the applicant in the year of award fails in the annual examinations conducted by affiliating university but is allowed to keep terms for the subsequent academic year (i.e. Fails- ATKT), the applicant shall not be eligible for the award of scholarship amount for that subsequent academic year. However the awardee may be considered again for the award of scholarship amount in the forthcoming next academic year if he /she fulfills all the conditions as mentioned in 4.6 above for the academic year in which the award was suspended.

For Example: If the applicant is awarded a scholarship for the first year & goes to second year with a University examination result as fails ATKT, then the award of scholarship to the applicant during second year Engineering will be suspended. However the awardee may be considered eligible for applying for such a scholarship at the third year engineering if he or she fulfills all the condition stated in 4.6 above at Second year engineering level.

4.8 If the applicant is awarded with the scholarship and fails at any level during the course then he/ she will not be eligible to apply for continuation of the award of scholarship.

4.9 The KJ's Educational Institute will consider the application for continuation of award of scholarship, provided the Principal/ Director of awardee's Institute has no objection for continuation of such an award after fulfilling necessary conditions, on the grounds of disciplines. The decision of the management in this respect will be final.

5. KJ's Educational Institute (The Trust) reserve the right to reject any or many or all applications received for award of scholarship. KJ's Educational Institute also reserves the right to award scholarship in full or partially to any or many, or all applications received.

6. All the applications must be submitted at the Trust office on or before 5pm on 10th August, 2016.
