PRESS NOTE

It is hereby notified that the State Level National Means-cum-Merit Scholarship Scheme Examination for class VIII will be conducted on 03-11-2019(Sunday) from 9.30 AM to 12.30 PM in Telugu/ Hindi/ Urdu/ English media at all Revenue Divisional Head Quarters of all 33 Districts in the State. **Online Applications are invited** for this examination from this office website "<http://bse.telangana.gov.in>". User guide to register the applications of the candidates **online**, to take print out of registered applications and Nominal Rolls, procedure for payment of examination fee, Head Master Instructions, due dates, and general guide lines of NMMS scheme are available in the same website.

I) **ELIGIBILITY:** A candidate who has/is

- (i) Scored at least 55% of marks, in case of SC/ST 50% of marks or equivalent grade i.e., B⁺ for all categories in class VII Examination studied during the year 2018-19.
- (ii) Studying in ZP/Government /Local Body /Government aided schools Model Schools which have no residential facility only can apply.
Candidates from Model Schools who have residential facility are not eligible for applying of NMMSE. Head Masters concerned will be held responsible in this matter.
- (iii) The candidates whose parental annual income (both Parents put together) is below Rs.1,50,000/- from all sources have to produce latest original Annual Income Certificate issued by the MRO,Telangana in case of Private employee and certificate issued by the employer in case of Government employee.
The students studying in Telangana Residential High Schools, Telangana Social Welfare Residential Schools, Telangana Tribal Welfare Residential High Schools, Telangana Minority Residential Schools, Government Ashram High Schools and Kasturba Residential Schools, Model schools with residential facility, Jawahar Navodaya Vidyalayas, Kendriya Vidyalayas, Private unaided Schools and other Government schools which have residential facility **are not eligible to appear for this Examination.**
- (iv) In case of BC/SC/ST candidates caste certificate (issued by the MRO of Telangana state) and in case of PHC candidates Medical certificates issued by District Medical board of Telangana state should be uploaded along with application at the time of registration of application on line and all the candidates including general candidates should upload income certificate (issued by the MRO of Telangana state) at the time of registration of application on line.
- (v) Candidate has also to submit the Original VII class Pass Memo of Marks to the Headmaster.
- VI) **Examination fee is** : Rs.100/- for OC/BC students & Rs. 50/- for SC/ST/PH students. The examination fee has to be paid through the system of **SBI Collect** which is connected with the link of online application.

The following are the **due dates** for remittance of exam fee and for submission of applications.

2	Last date for submission of printed copy of online registered Application Forms and NR (two copies) and fee receipts of SBI collect by the Head Masters of the schools concerned in the office of concerned District Educational Officer. (Printed Application form & NR must be attested by concerned Head Master.) (Attested copy of the caste certificates in case of BC/SC/ST and medical certificates in case of PH candidates should be enclosed. Otherwise they will be treated as General candidates) Income certificate for all candidates should be enclosed otherwise their application will be cancelled/rejected.	: 30-08-2019
3	Last date for submission of Printed Nominal Rolls attested by concerned Head Masters, and fee receipts of SBI collect by the concerned DEOs to the O/o the Director of Government Examinations., T.S., Hyderabad.	: 31-08-2019
